Dear Sir,

For the *now third time* in the *past three years* there is yet another news indicating disturbing developments. This relates to the MHRD's support for a project KHOJ between 2010 and 2014. If you may recall, on December 28, 2016 I had taken the liberty of writing to your Hon'ble self when yet another such news report had appeared suggesting a continued witch-hunt against me. I attach a copy of the earlier letter for your kind reference. **(Annexure 1)**

At the time, news reports had suggested that, through an unfortunate and misguided interpretation of the work that Sabrang Trust has been doing in schools all over the country, I, as author of some of the materials produced over the years would be 'booked for promoting hatred' and a criminal case likely to be filed against me. Now, another news report appearing yesterday (Business Standard based on PTI report) suggests that Rais Khan Pathan a former employee of CJP who appears to be functioning as a stooge of the central regime, has once again approached the Crime Branch of the Ahmedabad police with a 'complaint regarding' a project given by the Ministry of Human Resources Development (MHRD) between 2010-2013 to the Khoj Project of the Sabrang Trust. I would like to strongly contest these attempts by a person completely without jurisdiction or qualification to launch such a witch-hunt against me. Not only do I strongly contest the malafide charges but am writing this letter --again-- to inquire about the contents of what I believe to be a voluminous report (Bari Committee) absent from the public domain but which is being selectively quoted in sections of the media. It would be the interests of natural justice that this report that appears to be in selective hands is also made available to us.

For your information, the Khoj project and many of the relative writings were sponsored by the MHRD during the period of the central government grant and were duly reported to the Ministry annually. I would also like to categorically say that none of my writings can be construed as hate speech and in case any of the writing is so construed the same may be pointed out so that a suitable explanation can be given by me to the MHRD to avoid any unnecessary legal steps. In 2001, when a similar controversy was attempted to be raked up in Maharashtra, the Maharashtra State Human Rights Commission (SHRC) after studying our manuals had completely cleared us of any vile charge. Now 17 years later a matter is sought to be raked up by a person who is obviously a tool in malicious hands.

I would also like to take an opportunity to assert very strongly that both individually and our organisations have been devoted to furthering the constitutional objectives in all areas of our work. The rich and contested traditions of Indian intellectual growth embodied in the writings of Jyotiba Phule, Dr B.R. Ambedkar --especially in seriously contested areas of social sciences and history have given us inspiration.

We are hopeful of a response from your ministry, Sir.
