Instructions are sought due to an important aspect having emerged today at the time of hearing, inasmuch as, although the petitioner Phuljan Nessa, wife of Innas Ali, of Village No.1 Garumara, P.S. Samaguri, in the district of Nagaon has been declared as a foreigner of post 1971 stream vide impugned order/opinion dated 25.10.2017 of the Foreigners' Tribunal,(2nd), Nagaon in F.T. Case No.146/2016, now it is seen that despite being declared as a foreigner, as against "ARN: 101830502032209400628", the name of Phuljan Nessa has been entered in the National Register of Citizens.
