According to the prosecution, there is prima facie evidence against accused no.1 Anand for the offences punishable under Section 120-B, 115, 121, 121-A, 124, 153-A, 201, 505(1) (b) and 34 of the IP Code and Sections 13, 16, 17, 18, 18-B, 20, 38 and 39 of the UAP Act. It is claimed that further there is prima facie evidence against accused No.2, Gautam for the offences punishable under Section 120-B, 115, 121, 121-A, 124, 153-A, 201, 505(1) (b) and 34 of the IP Code and Sections 13, 16, 18, 20, 38 and 39 of the UAP Act. Further there is prima facie evidence against accused No.3 Hanyf for the offences punishable under Section 120-B, 115, 121, 121-A, 124-A, and 34 of the IP Code and Sections 13, 16, 17, 18, 20, 38, 39 and 40 of the UAP Act. It is claimed that further there is prima facie evidence against accused No.4, Sagar for the offences punishable under Section 120-B, 115, 121, 121-A, 124-A, 153-A, 505(1) (b) and 34 of the IP Code and Sections 13, 16, 18, 20, 38 and 39 of the UAP Act. It is claimed that further there is prima facie evidence against accused No.5, Ramesh for the offences punishable under Section 120-B, 115, 121, 121-A, 124-A, 153-A, 505(1) (b) and 34 of the IP Code and Sections 13, 16, 18, 20, 38 and 39 of the UAP Act. It is claimed that further there is prima facie evidence against accused No.6, Jyoti for the offences punishable under Section 120-B, 115, 121, 121-A, 124-A, 153-A, 505(1) (b) and 34 of the IP Code and Sections 13, 16, 18, 20, 38 and 39 of the UAP Act. It is claimed that further there is prima facie evidence against accused No.7, Stan Swamy for the offences punishable under Section 120-B, 115, 121, 121-A, 124-A and 34 of the IP Code and Sections 13, 16, 18, 20, 38 and 39 of the UAP Act. In view of the aforesaid allegations and considering the material available on record, I find that there is prima facie material on record against the accused person for taking cognizance for the offence mentioned in the aforesaid paragraphs.
